ROMGAZ Auditorium was inaugurated at Bucharest University of Economic Studies (ASE). This was a project of the Students' in Economy, Business and Communication Association (ASEAC) supported by S.N.G.N. Romgaz S.A. (ROMGAZ) and the Faculty of Theoretical and Applied Economics.
